
**October 2, 2023**

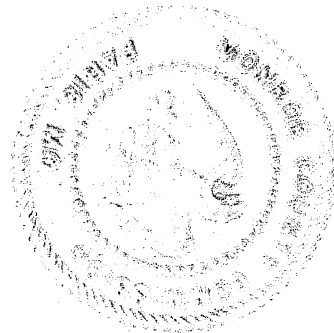

6. Commission to discuss the purchase of the Co-Op building for Road & Bridge purposes. Tabled until next meeting scheduled for 10/19/2023.


