December 4, 2023



5. Commission met with Associate Judge, Talley Smith for budget clarification, and salary commission discussion.



5. Commission spoke with Bradly Sprocket and Danielle Rossier about Cybersecurity and the Verkada Security installation has begun.



Public Hearing Minutes



Monroe County Commissioners Mike Whelan, and Curt Wheeler, met with Cheryl Hannah from Middle Grove Cemetery Board member and Monroe County Treasurer, Sheila Jurgesmeyer, in regards to Monroe County overseeing the financial upkeep of the Middle Grove Cemetery.

As discussed, Cheryl asked that \$1000.00 be set aside as principle in a C.D. for the cemetery as principle should be reserved.

As of present, there is no regular mower for the cemetery, and depending on the weather/season, the cemetery is willing to pay \$200/time of mowing. Sheila provided invoice sheets for the purpose of mowing records and etc. Mike recommended keeping \$5000.00 in a checking account in an interest bearing account.

Currently, most banks are paying interest rates of 4%-5%, for a checking account and comparable rates for short term and long term C.D.s.

Sheila requested Cheryl to notify her when there is a change in Board members and other changes as they occur.
