Commissioners Present: Presiding, Curt Wheeler, Western District, Marilyn O'Bannon, Eastern District, Mike Whelan.


Minutes from the previous meeting were approved.

7. Commission discussed a maintenance issue with Israel Campbell.








MONROE COUNTY COMMISSION MINUTES

8. Commission scheduled a meeting with MODOT for the Show-Me presentation on March 6, 2023 @ 1:30 p.m.


