





6. Commission discussed the janitor position that remains open.







6. Commission met with Nicole Volkert by phone about the staff meeting on 3/9/2023.



Minutes from March 23, 2023


Commission approved minutes from the previous meeting.

Commission met with Randy Owen in regard to his agency providing legal services for the County. Discussion included ordinances on wind and solar energy, and other topics.



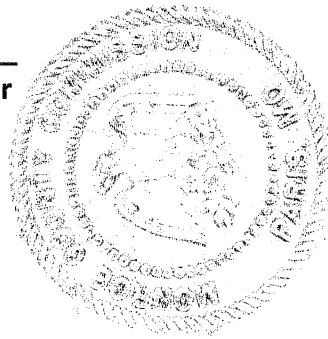
