July 3, 2023




MONROE COUNTY COMMISSION MINUTES

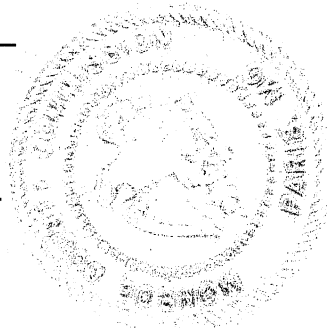


July 13, 2023

8. Commission notified all Monroe County Fire District officials.


